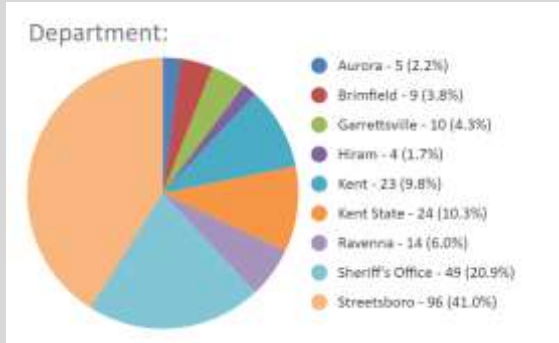

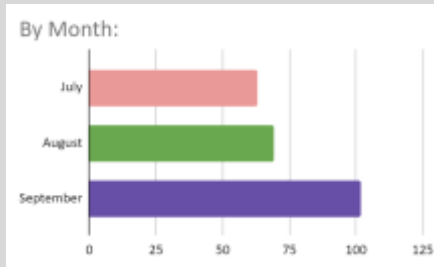

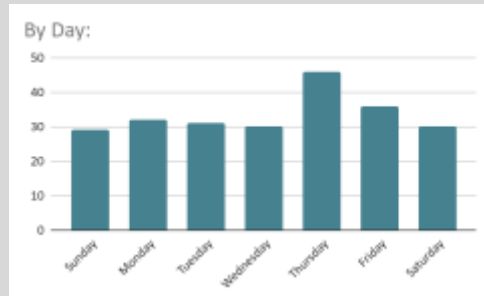
A significant increase in calls during September compared to July and August

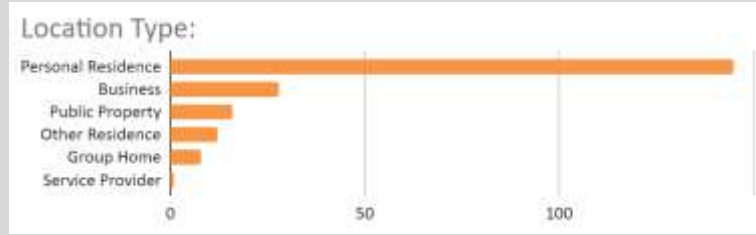

A trend that most calls take place at one's personal residence

Personal Residence - The place where a subject lives or is currently residing.

Other Residence - Any other residence where a subject was located when the call of service occurred. **Group Home** - A residence where unrelated people who cannot adequately manage on their own or in their own homes live together for care, support, or supervision.

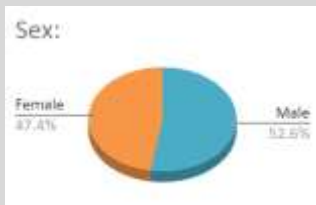
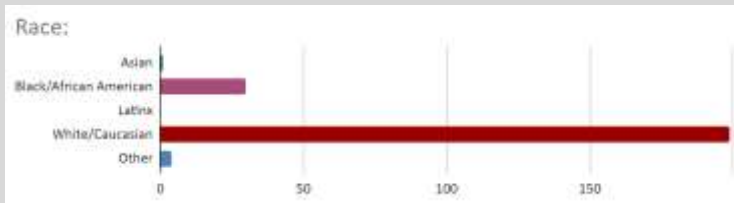
Business - A location engaged in commercial, industrial, or professional activities.

Service Provider - Locations that provide mental health services such as assessment, treatment, and stabilization.

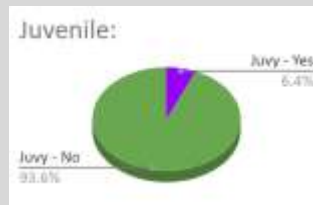
Public Property - Property that is dedicated for public use (sidewalks, parks, roadways, etc.)

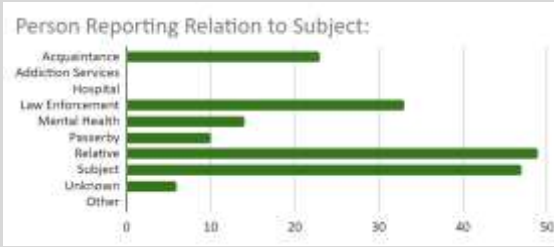

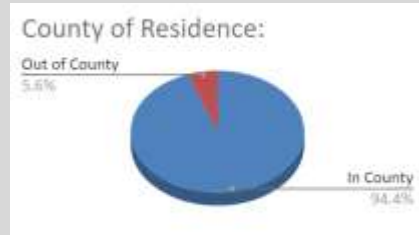

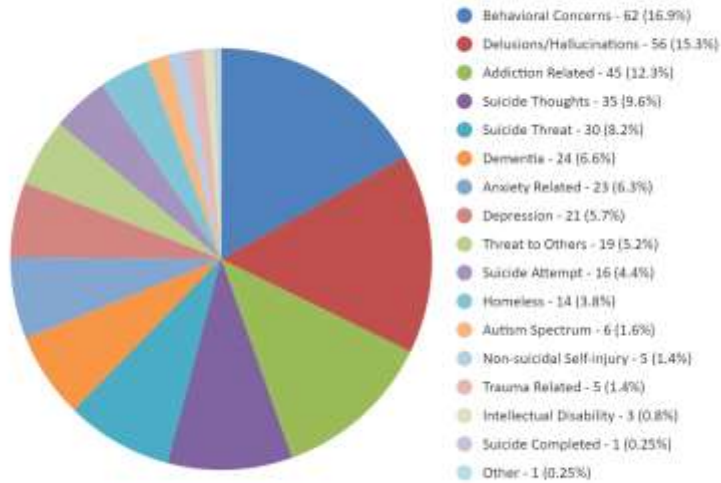
Person Reporting Relation to Subject: The type of agency reporting or the reporting person's relationship to the subject for the call for service.

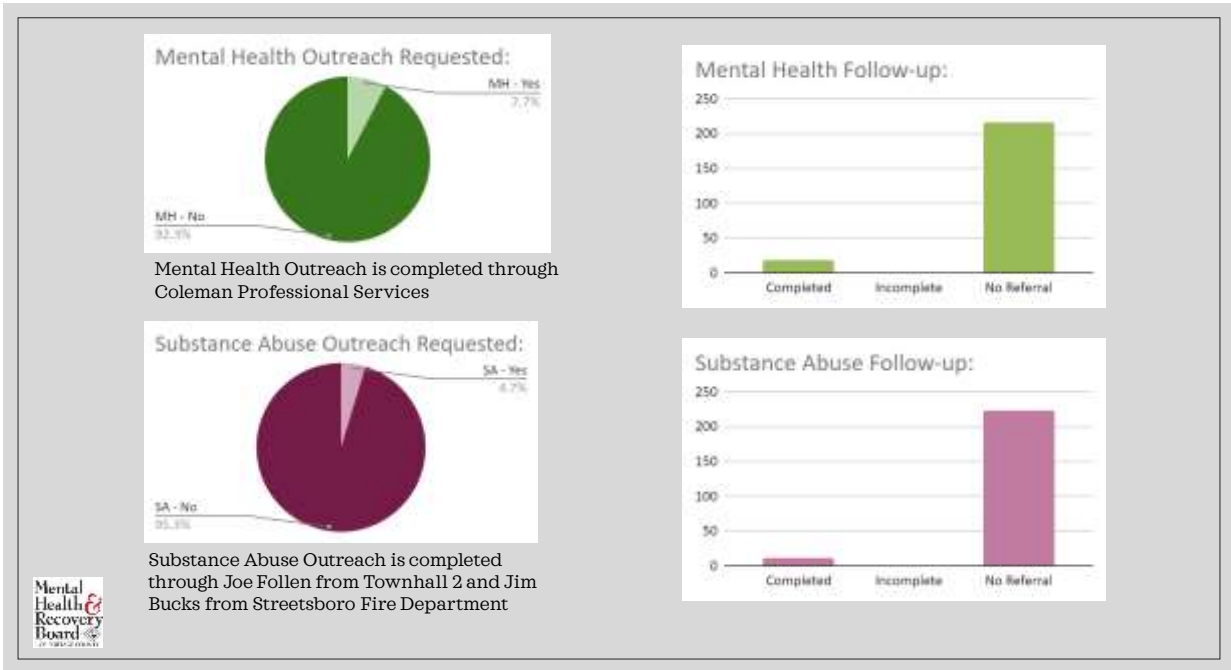
